STANDARD RULES

ADHOC

PARTIES AGREE THE PROCEDURE, COSTS AND TIMELINES WITH THE ARBITRATOR(S) AND THE LCA PROVIDES SERVICES SUCH AS THE APPOINTMENT OF ARBITRATORS, TRIBUNAL SECRETARIES, TRANSCRIPTION AND FUND HOLDING.

THE PARTY FILING A REQUEST FOR ARBITRATION MUST INCLUDE WITH THE REQUEST A NON-REFUNDABLE REGISTRATION FEE OF **N200,000.00** ONLY.

ADMINISTERED ARBITRATION

THE LCA ADMINISTERS THE PROCESS TO ENSURE INTEGRITY AND ENFORCEABILITY. THE PARTY FILING A REQUEST FOR ARBITRATION MUST INCLUDE WITH THE REQUEST A NON-REFUNDABLE REGISTRATION FEE OF **N200,000.00** ONLY. THE LCA ADMINISTRATIVE FEES ARE SET AT THE BEGINNING OF THE PROCEEDINGS AND A SCALE OF FEES CAN BE REQUESTED AT THE RECEPTION. ARBITRATOR FEES ARE PAID IN ADDITION TO THE LCA ADMINISTRATIVE FEES AND THE ARBITRATOR WILL CHOOSE TO CHARGE ACCORDING TO TIME OR VALUE SCALES. THE LCA ARBITRATOR SCALE OF FEES CAN BE REQUESTED AT THE RECEPTION

EXPEDITED RULES

THE SYSTEM IS DESIGNED TO HAVE THE DISPUTE RESOLVED SPEEDILY AND IN THE SHORTEST TIME THAT JUSTICE AND FAIR PLAY PERMITS. THE LCA ADMINISTERS THE PROCESS TO ENSURE INTEGRITY AND ENFORCEABILITY. THE PARTY FILING A REQUEST FOR ARBITRATION MUST INCLUDE WITH THE REQUEST A NON-REFUNDABLE REGISTRATION FEE OF **N100,000.00** ONLY. THE LCA EXPEDITED ADMINISTRATIVE FEES ARE SET AT THE BEGINNING OF THE PROCEEDINGS AND A SCALE OF FEES CAN BE REQUESTED AT THE RECEPTION. EXPEDITED ARBITRATOR FEES ARE PAID IN ADDITION TO THE LCA EXPEDITED ADMINISTRATIVE FEES AND THE ARBITRATOR WILL CHOOSE TO CHARGE ACCORDING TO TIME OR VALUE SCALES. THE LCA ARBITRATOR SCALE OF FEES CAN BE REQUESTED AT THE RECEPTION

SMALL CLAIMS

THE SYSTEM IS DESIGNED FOR THE ADMINISTRATION OF DISPUTES WITH THE MONETARY VALUE OF N5 MILLION AND BELOW. THE SYSTEM IS DESIGNED TO HAVE THE DISPUTE RESOLVED SPEEDILY AND IN THE SHORTEST TIME THAT JUSTICE AND FAIR PLAY PERMITS. THE LCA ADMINISTERS THE PROCESS TO ENSURE INTEGRITY AND ENFORCEABILITY. THE PARTY FILING A REQUEST FOR ARBITRATION MUST INCLUDE WITH THE REQUEST A NON-REFUNDABLE REGISTRATION FEE OF **N25,000.00** ONLY. THE LCA EXPEDITED ADMINISTRATIVE FEES ARE SET AT THE BEGINNING OF THE PROCEEDINGS AND A SCALE OF FEES CAN BE REQUESTED AT THE RECEPTION. EXPEDITED ARBITRATOR FEES ARE PAID IN ADDITION TO THE LCA EXPEDITED ADMINISTRATIVE FEES AND THE ARBITRATOR WILL CHOOSE TO CHARGE ACCORDING TO TIME OR VALUE SCALES. THE LCA EXPEDITED ARBITRATOR SCALE OF FEES CAN BE REQUESTED AT THE RECEPTION

MEDIATION

STANDARD GUIDELINES

THE PARTY FILING A REQUEST FOR MEDIATION SHALL INCLUDE WITH THE REQUEST A NON-REFUNDABLE REGISTRATION FEE OF **N24,000**. NO REQUEST FOR MEDIATION SHALL BE PROCESSED UNLESS ACCOMPANIED BY THE REQUISITE PAYMENT. MEDIATOR FEES ARE PAID IN ADDITION TO THE LCA ADMINISTRATIVE FEES AND ARE SET AT THE BEGINNING OF THE PROCEEDINGS. THE MEDIATOR FEES WILL BE NEGOTIATED AT THE BEGINNING OF THE PROCEEDING TAKING INTO ACCOUNT MATTERS SUCH AS THE COMPLEXITY OF THE CASE AND THE ESTIMATED AMOUNT OF TIME LIKELY TO BE INVOLVED, ETC. THE LCA ADMINISTRATIVE FEE IS A FIXED CHARGE OF N72,000.00. MEDIATOR FEES ARE BASED ON A MINIMUM HOURLY RATE OF N100,000.00 TO A MAXIMUM OF N250,000.00

EXPEDITED GUIDELINES

THE SYSTEM IS DESIGNED TO HAVE THE DISPUTE RESOLVED SPEEDILY AND IN THE SHORTEST TIME THAT JUSTICE AND FAIR PLAY PERMITS. THE PARTY FILING A REQUEST FOR MEDIATION SHALL INCLUDE WITH THE REQUEST A NON-REFUNDABLE REGISTRATION OF **N24,000**. NO REQUEST FOR MEDIATION SHALL BE PROCESSED UNLESS ACCOMPANIED BY THE REQUISITE PAYMENT. MEDIATOR FEES ARE PAID IN ADDITION TO THE LCA ADMINISTRATIVE FEES AND ARE SET AT THE BEGINNING OF THE PROCEEDINGS. THE MEDIATOR FEES WILL BE NEGOTIATED AT THE BEGINNING OF THE PROCEEDING TAKING INTO ACCOUNT MATTERS SUCH AS THE COMPLEXITY OF THE CASE AND THE ESTIMATED AMOUNT OF TIME LIKELY TO BE INVOLVED, ETC. THE LCA ADMINISTRATIVE FEE IS A FIXED CHARGE OF N72,000.00. EXPEDITED MEDIATOR FEES ARE BASED ON A MINIMUM HOURLY RATE OF N50,000.00 TO A MAXIMUM OF N75,000.00
